Include UCCI in Your Will or Trust

Designate a specific sum, a percentage of your estate, or assets to UCCI in your will or trust. Example language: "I give, devise, and bequeath to United Church Camps, Inc. (UCCI), Tax ID # 39-0927520, a not-for-profit organization, located in Ripon, Wisconsin, the sum of \$ dollars (OR, ___ percent of the rest, residue, and remainder of my estate), for its general purposes to be used and/or disposed of as UCCI may in its sole discretion deem appropriate."

Transfer Bank or Investment Accounts

Name UCCI as the "payable on death" or "transfer on death" beneficiary to ensure a seamless transfer of these assets to support our mission.

Life Insurance Policy

Make UCCI a beneficiary of your life insurance policy.

Retirement Account

Designate UCCI as a beneficiary of your retirement account and/or recipient of your required minimum distribution. Charities do not pay income tax, so the entire amount of your retirement account will directly benefit UCCI.

Charitable Gift Annuity

Establish a charitable gift annuity, providing you with a stream of income during your life, with the remaining funds benefiting UCCI upon your passing.
